

DECLARATION OF COMPLIANCE FOR SEMI-FINISHED PRODUCTS INTENDED TO COME INTO CONTACT WITH FOOD

Vink Plast ApS hereby declare that:

Ketron TX PEEK FCM blue, round rods and plates and finished parts machined from these products by Vink Plast ApS ²⁾:

European Union

- Comply with the requirements of the articles 3, 11(5), 15 and 17 of the regulation (EC) no. 1935/2004
- Comply with the relevant requirements in Regulation (EU) 10/2011 as amended up to and inclusive the commission Regulation (EU) no. 2020/1245
- Are manufactured and handled according to good manufacturing practice (GMP) as set out in the (EC) 2023/2006 of 22 December 2006 on good manufacturing practice for materials and articles intended to come into contact with food.
- Comply with declaration 681/2020/DK

Based on the migration tests performed on the products according to Regulation (EU) 10/2011 as amended, the overall migration as well as the specific migration does not exceed the legal limits set out in Regulation (EU) 10/2011, when used as specified below.

Specification on the intended use of the products:

 - 10 % ethanol (4 h at reflux temperature)
 - Vegetable oil (2 h at 175 °C) ⁴⁾
 - Visible migration tests run according to the analytical method described in the Appendix of European Resolution AP (89)1, «On the use of colorants in plastic materials coming into contact with food,» dated September 13, 1989, under III.1.
- Ratio of food contact surface area to volume (S/V) used to establish the compliance of the Products:

A risk assessment of the Non-Listed Substances (NLS), such as catalysts and Non-Intentionally Added Substances (NIAS), such as reaction and degradation products has been performed in accordance with Article 3 of the Framework Regulation ((EU) 1935/2004) and article 19 of the Plastic Regulation ((EU) 10/2011) and Article 3.5 of GB 4806.1-2016 based on the conditions mentioned above.

United States

We hereby provide the following information on the compliance status of the raw materials used at present by the producer for the manufacture of the stock shapes mentioned above, with respect to their composition, as set out in regulations that apply in the United States of America (FDA) for plastic materials and articles intended to come into contact with foodstuffs:

- Ketron TX PEEK FCM blue complies with the compositional requirements of the FDA regulations 21 CFR § 177.2415 "Poly(aryletherketone) resins." And 21 CFR § 178.3297 "Colorants for polymers," as well as with those other applicable FDA regulations.
- Based on their composition, Ketron TX PEEK blue black stock shapes may basically be used for the manufacture of articles or components of articles intended for repeated food-contact use with all types I to IX, except with infant formula and breast milk, under conditions of use A to H as defined in tables 1 and 2 in 21 VFR 176.170 (c), respectively.

Japan

Based on the compliance status of the raw materials used at present by the manufacturer, for the manufacture of the stock shapes mentioned above, with respect to their composition, as set out by the Japan's Ministry of Health, Labour & Welfare (MHLW) in the Official Notification (Notification no. 196 of 2929) of 28 April 2020 for utensils, containers and packaging intended to come into contact with food stuffs:

- Ketron TX PEEK FCM blue complies with the compositional requirements of the 'Base polymers (Plastics)' and 'Additives' Japan food contact positive lists. Based on their composition, Ketron TX PEEK FCM blue stock shapes may basically be used for the manufacture of articles or components of articles intended for food contact use with all food types, under maximum temperature conditions III.

It remains the responsibility of the customer putting the plastic article manufactured from the products into the intended use, to assess the final suitability of the plastics material for the intended food contact application; i.e. checking if the physical properties of the plastics material make it suitable for the intended application, checking compliances of the finished plastic article with the relevant migration limits, checking for possible influence of the plastics material on the composition and/or organoleptic properties of the contacting foodstuff, etc.

- ⁴⁾ Specific migration tests in vegetable oil (2 h at 175 °C) being replaced by tests in isooctane (4 h, 60 °C), 95 % ethanol (6 h, 60 °C) and MPPO (2 h, 175 °C) in accordance with Directive 82/711/EEC as vegetable oil is technically not feasible with the used methods of analyses.
