#### 1. Determination of the Overall Migration

The determination was carried out according to the methods for the "Examination of consumer goods" corresponding to directives B 80.30, 1 to 3 (EG) of the Official Collection of Analytical Methods according to § 64 LFGB and according to the rules of the series of standards EN 1186 end EN 13130. The choice of the tests stimulants as well as the contact conditions was performed according to requirements of annex III and V of Commission Regulation (EU) No 10/2011 on "Plastic materials and articles intended to come into contact with food".

If not stated differently, the results are given as average values of determination in triplicate.

Conditions: 10 days at 60°C

Test stimulants: Acetic acid, 3 % (W/W) (foodstuff stimulant B)

Ethanol 10% (v/v) (foodstuff stimulant A) Ethanol 50% (v/v) (foodstuff stimulant D1)

Ethanol 95 % (v/v) (Screening) Tenax ® (foodstuff stimulant E)

Testing procedure: One-sided contact (coated side)

Results: Acetic acid 3 % (w/w): not determinable < 2 mg/dm<sup>2</sup>



<sup>&</sup>lt;sup>1)</sup> The portion adsorbed onto tenax was determined gravimetrically after extraction with diethyl ether. A single determination was carried out.
