

DECLARATION OF COMPLIANCE FOR SEMI-FINISHED PRODUCTS INTENDED TO COME INTO CONTACT WITH FOOD

Vink Plast ApS hereby declare that:

Vivak[®] Clear 099 FCM/ Vivak[®] Eco Clear 099 FCM (PETG) sheets and finished parts machined from these products by Vink Plast ApS ²):

comply with:

- the requirements of EU regulation 1935/2004/EU
- Good manufacturing practice (GMP), EU 2023/2006 which are considered appropriate for plastic raw materials as required by Regulations.
- According to Article 19, regulation (EC) 10/2011 and amendment to date ((EU) 2020/1245 on plastic materials and articles intended to come into contact with food..

Use conditions

The above mentioned limits have met in exemplary investigations on sheets. Conditions for both overall migration and specific migration:

- Simulants: A, B and D2
- Duration: 10 days
- Temperature: 40 °C
- 4.3 dm²/liter simulant

The declaration of compliance is only valid for the temperature/time as described. It is the responsibility of the user of our products, who manufactures materials or articles intended for food contact or brings them into contact with food, to assure their compliance with limits and other provisions set by the applicable regulations.

Risk Assessment:

Risk assessment has been performed according to Article 19 regulation (EU) 10/2011 for the following use conditions for all food types (Simulants A, B and D2):

- Up to 70 °C for up to 2 hours.
- Up to 40 °C for up to 30 days.
- All storage times at refrigerated and frozen conditions.

It is the responsibility of the user of our products, who manufactures materials or articles intended for food contact or brings them into contact with food, to perform risk assessment according to article 19 of Commission Regulation (EU) 10/2011 for their own specific use conditions.
