

## Perspex<sup>®</sup> 10 Year Guarantee Extruded Acrylic Sheet

## **Extruded Sheet**

Subject to the following conditions:

- Perspex<sup>®</sup> XT clear sheets show a light transmission reading after 10 years which is at least 88%. (Measurement acc. DIN 5036, T.3 on samples 3mm)
- Perspex<sup>®</sup> XT sheets have a tensile modulus after 10 years of > 2800 N/mm<sup>2</sup> (measurement acc. DIN 53455-t on samples 4mm)
- Perspex<sup>®</sup> XT sheets show a tensile strength at break of > 60 N/mm<sup>2</sup> after 10 years. (Measurement acc. DIN 53455 on samples 4mm)

## THIS GUARANTEE IS VALID FOR ALL EU COUNTRIES

To be covered by the guarantee  $\ensuremath{\mathsf{Perspex}}^{\ensuremath{\mathbb{R}}}$  XT sheets must be:

- 1. Stored, transported, treated and installed correctly.
- 2. Protected from adverse weather conditions during fixing, fastening or sealing.
- 3. Protected from damaging chemicals, especially from powerful solvents and cleaners.

This guarantee refers to unformed sheets without subsequent surface treatment which are free from damage to the surface caused by scratches or rough handling.

A complaint can only be considered if it is made within the guarantee period and on production of the supplier's invoice which includes the name and address of the purchaser, the date of purchase as well as the complete product description and product identification.

Perspex International must be given immediate notice of any complaint. Sufficient evidence of the complaint must be given to Perspex International and those authorised by it must be allowed adequate facilities to substantiate any complaint. Perspex International gives no guarantee or warranty express or implied in relation to Perspex<sup>®</sup> acrylic sheet apart from the guarantee given herein.

This guarantee and all the terms thereof shall apply to all deliveries of Perspex<sup>®</sup> supplied by Perspex International until the guarantee is revoked by either of the parties. Revocation may be effected by either party serving on the other notice in writing to that effect at any time. Revocation shall not affect deliveries of sheet made prior to the date of revocation which shall continue to be fully covered by the terms of this guarantee.

## Perspex<sup>®</sup> Guarantee

If any Perspex<sup>®</sup> XT acrylic sheet shall be shown to Perspex International satisfaction to have failed to comply with the said performance specifications within the stipulated time limit Perspex International shall replace the failed sheet with an equivalent amount of Perspex or other suitable alternative sheet to be delivered free of charge by Perspex International to a delivery point to be nominated by the customer, but Perspex International shall under no circumstances be responsible for any other damage or loss howsoever arising whether directly or indirectly. The guarantee period runs from the date of delivery of the sheet to the customer.
